

NEFFUL USA'S 19th ANNUAL AWARDS REQUIREMENTS (2021)

1) NET

NET	US\$3,333,333 and above

2) AGM Annual Awards

Super Diamond	US\$2,750,000~US\$3,333,333
Diamond	US\$2,416,666~US\$2,750,000
Super Platinum	US\$2,083,333~US\$2,416,666
Platinum	US\$1,750,000~US\$2,083,333
Double Gold	US\$1,416,666~US\$1,750,000
Gold	US\$1,083,333~US\$1,416,666
Silver	US\$750,000~US\$1,083,333

◆ Sales Volume Calculation Method:

- Personal AGM Organization Volume X 100%
- First Generation AGM Organization Volume X 60%
- Second Generation AGM Organization Volume X 40%
- Third Generation AGM Organization Volume X 20%

◆ The following 2 criteria must be achieved to attain the AGM Annual Awards:

1. The calculation is based on the qualifying first generation AGMs (qualifying First Generation AGM refers to downline AGM with Group Volume of at least US\$10,000 in one single country), AGM's own Organization Volume must qualify for the following volume:

No. of FirstGeneration AGM	Minimum Requirement of Annual AGM Own Organization Volume
0	US\$750,000
1	US\$466,667
2	US\$400,000
3	US\$333,334
4	US\$216,667
5	US\$100,000
6 & above	US\$30,000

2. AGM has to achieve an Annual Group Volume of at least US\$10,000 in one single country.

3、AGM Sales Award (2021.01~2021.12)

Award	Annual Organization Volume
Eminence Award	US\$533,334 & above
Esteem Award	US\$466,667~US\$533,334
Jubilant Award	US\$333,334~US\$466,667 And have at least 1 AM+ from your own organization advance to AGM

If awardees are qualified for both NET or AGM Annual Awards, they will not be eligible for AGM Sales Award ◦

4、AM Awards (2021.01~2021.12)

Award	Annual Organization Volume	Annual Group Volume
AM Sales Award	US\$160,000 & above	US\$100,000 & above
AM Inspiration Award	US\$120,000 ~ US\$160,000	US\$66,667 & above

Both Annual Organization Volume and Annual Group Volume must be achieved to be eligible.

◎Above sales volume calculation is based on internationally combined figures (US\$).

◎The number of award winners shall not be limited/restricted.

◎Above annual sales award requirements may be altered in accordance to the yearly sales volume variation.
